#### YOU AGREE TO BE BOUND BY THE TERMS OF THIS EULA BY INSTALLING, COPYING OR OTHERWISE USING THIS PRODUCT. IF YOU DO NOT AGREE, DO NOT INSTALL OR USE THE PRODUCT.

In addition, by installing, copying or otherwise using updates that you receive as part of the Product ("Updates"), you agree to be bound by the additional licence terms that accompany such Updates. ### 1.1 TaxCalc Personal (2009)

1.1.1 Use of this product is authorised to one individual according to the terms of this EULA.

# 1.1.2 The Product may NOT be used on a professional basis i.e. not to be used for any fee based tax preparation services or to assist in providing tax or financial advice to clients.

- 1.1.3 You may use the Product to prepare up to six tax returns, comprising any combination of the SA100 series return forms and the R40 repayment return.
- 1.1.4 If you have purchased the appropriate upgrade or product variation, you may prepare up to six additional SA100/R40 returns; and/or one, two or five SA900 trust tax returns.
- 1.1.5 The Product is intended only for use:
  - (i) within the United Kingdom; and
  - (ii) for the tax year 2008-09.

Any use of the Product outside of the United Kingdom and/or for a tax year other than as identified, is at your own risk and, to the maximum extent permitted by applicable law, ASP accepts no liability for any resulting losses suffered by you.

### 1.2 TaxCalc Lite (2009)

- 1.2.3 You may use the Product to prepare one tax return, comprising of either an SA100 series return (SA100 core return plus the Employment pages and certain Additional Information boxes) or an R40 repayment return, subject to a maximum total income of £30,000.
- 1.2.4 The Product is intended only for use:
  - (i) within the United Kingdom; and
  - (ii) for the tax year 2008-09.

Any use of the Product outside of the United Kingdom and/or for a tax year other than as identified, is at your own risk and, to the maximum extent permitted by applicable law, ASP accepts no liability for any resulting losses suffered by you.

### 1.3 TaxCalc Partnership (2009)

- 1.3.5 The Product is intended only for use:
  - (i) within the United Kingdom; and
  - (ii) for the tax year 2008-09.

- 1.4.4 If you have purchased the appropriate upgrade or product variation, you may prepare up to six additional SA100/R40 returns; and/or one additional CT600 limited company tax return; and/or one or two SA900 trust tax returns.
- 1.4.5 The Product is intended only for use:
  - (i) within the United Kingdom; and
  - (ii) for the period to 30 April 2010 for forms CT600; and
  - (iii) for the tax year 2008-09.

- 1.5.3 If you have purchased the appropriate upgrade or product variation, you may prepare an unlimited number of SA900 trust tax returns; and/or use the Product over a network; and/or allow more than one user.
- 1.5.4 The Product is intended only for use:
  - (i) within the United Kingdom; and
  - (ii) for the tax year 2008-09.

Any use of the Product outside of the United Kingdom and/or for a tax year other than as identified, is at your own risk and, to the maximum extent permitted by applicable law, ASP accepts no liability for any resulting losses suffered by you.

- 1.6.3 If you have purchased the appropriate upgrade or product variation, you may prepare an unlimited number of SA900 trust tax returns; and/or use the Product over a network; and/or allow more than one user.
- 1.6.4 The Product is intended only for use:
  - (i) within the United Kingdom; and
  - (ii) for the period to 30 April 2010 for forms CT600; and
  - (iii) for the tax year 2008-09 for all other forms.

Any use of the Product outside of the United Kingdom and/or for a tax year other than as identified, is at your own risk and, to the maximum extent permitted by applicable law, ASP accepts no liability for any resulting losses suffered by you.

# 1.7 TaxCalc Trusts Solo (2009)

- 1.7.1 Use of this product is authorised to one individual according to the terms of this EULA.
- 1.7.2 The Product may NOT be used on a professional basis i.e. not to be used for any fee based tax preparation services or to assist in providing tax or financial advice to clients.
- 1.7.3 You may use the Product to prepare a single SA900 series trust tax return.
- 1.7.4 The Product is intended only for use:
  - (i) within the United Kingdom; and
  - (ii) for the tax year 2008-09.

Any use of the Product outside of the United Kingdom and/or for a tax year other than as identified, is at your own risk and, to the maximum extent permitted by applicable law, ASP accepts no liability for any resulting losses suffered by you.

#### 1.8 TaxCalc Unlimited Trusts (2009)

- 1.8.1 Use of this product is authorised to one firm or person according to the terms of this EULA.
- 1.8.2 You may use the Product to prepare an unlimited number of SA900 series trust tax returns.
- 1.8.3 The Product is intended only for use:
  - (i) within the United Kingdom; and
  - (ii) for the tax year 2008-09.

# **2 RIGHTS AND LIMITATIONS**

### 2.1 Limitation on Reverse Engineering, Decompilation and Disassembly

You may not reverse engineer, decompile or disassemble the Product.

#### 2.2 Termination

Without prejudice to other rights, ASP may cancel this EULA if you do not abide by the terms and conditions of this EULA, in which case you must destroy any copies of the Product and all of its component parts.

### 2.3 Not for Resale

- 5.2 TaxCalc requires a connection to the internet in order to file a tax return online and for the TaxCalc Update to function. It is your sole responsibility to establish and maintain adequate access and to provide and maintain all necessary equipment.
- 5.3 HM Revenue & Customs (HMRC) provides a service allowing the filing of certain tax returns online. ASP does not guarantee:
  - (i) that HMRC will continue such a service; and
  - (ii) the type of returns that the HMRC service will accept; and
  - (iii) the continuity of the HMRC service.
- 5.4 ASP is not in any way responsible for any interference with or interruption to your use of or access to the HMRC online filing service or TaxCalc Update. ASP may at any time change or discontinue any aspect of, availability or feature of its online functionality.
- 5.5 **You are responsible** for ensuring that the tax returns that you have submitted have been received and accepted by HMRC and, if necessary, for filing the tax returns manually.

# **6 DIVIDEND DATABASE**

- 6.1 You acknowledge that the Intellectual Property Rights in respect of the Dividend Database are owned by SIX Telekurs UK Limited and used by ASP under licence and that you have no rights to this information other than in the preparation of SA100 series returns.
- 6.2 In addition to clauses 3 and 4 of this EULA, both ASP, SIX Telekurs UK Limited and their respective suppliers of information accept no liability for the accuracy, completeness or appropriateness of the financial information supplied, or the services provided, or for the functioning of the software it puts at your disposal.

- 6.3 You acknowledge that you are supplied with historical data applicable only to the 2008-09 tax year.
- 6.4 You acknowledge that the Dividend Database is available in the SA100 and SA800 modules only.
